

The owners index alphabetically lists every person and company owning a property, or a substantial share in a property, in the area covered by Sydney Cityscope. The name of the person or company is followed by the Cityscope map and property reference and in the case of strata units, the unit number. Most properties appear more than once in the index - for instance, a property owned jointly by two private companies would be indexed under each of the company names and also under the names of the major shareholders and/or directors of each company. Refer back to the text entry to see exactly what interest the owner has in the property. People are indexed by surname, but companies are indexed by the first word or first string of letters - the person William Smith would appear under S, the company William Smith Holdings P/L under W. Spaces in a name or string of letters take precedence over letters - so K E G Holdings P/L would appear near the beginning of the K section, whereas KEG Holdings P/L would appear somewhere between Keating and Kelly. Company names which begin with numbers are indexed in a separate numeric section at the beginning, before the A section.
